

## Education Queensland International (EQI) International Student Programs (ISP) application cut-off dates 2023 to 2025 for complete applications\* (updated May 2023)

Applications open one year before the intended start date e.g. applications for July 2025 open in July 2024.

Schools approve student placements during Queensland school dates. Therefore, please be mindful of future school holidays when submitting applications to EQI (<https://education.qld.gov.au/about-us/calendar/future-dates>). The recommended submission dates and cut-off dates below factor in school holidays.

### Important information about application cut-off dates

- \* Complete applications are applications where all relevant fields have been completed, all required supporting documents are provided and complete status confirmed by EQI case officer.
- # Applications received after these dates will be considered on a case by case basis.
- The above dates do not include applications for Queensland Academies. (For future dates, monitor <https://qa.eq.edu.au/enrolments/year10-enrolments/year10-application-process>).
- For students seeking to start in January the following year and who are waiting on academic reports from their home country, the application should be lodged by the cut-off date and the reports provided before a Confirmation of Enrolment is issued.
- Please enquire first if wishing to apply after a cut-off date. EQI will make every effort to support an application within time, program, welfare, and visa application constraints. If the student visa is not granted in time to commence school at the required entry point, additional charges will be incurred for revision of the enrolment agreement.
- Allow extra time for visa processing if applying for welfare to be provided by a Department of Home Affairs (DHA) approved guardian as this process involves additional application requirements e.g. police checks.
